- The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (Annexure-I) and the Right of Children to Free and Compulsory Education Rules, 2011 (Annexure-II).
- The school shall admit in class I, to the extent of 25% of the strength of that class, children belonging to the weaker section and the disadvantaged group in the neighborhood and provide Free and Compulsory Elementary Education till its completion:

Provided, that in case of Pre-primary classes also, this norm shall be followed.

- 4. For the children referred to in paragraph 3, the school shall be reimbursed as per subsection 2 of section 12 of the Act. To receive such reimbursement, the school shall provide a separate bank account.
- The school shall not collect any capitation fee and subject the child or his or her parents or guardians to any Screening Procedure.
- 6. The school shall not deny admission -
 - (a) to any child for lack of age proof; or
 - (b) if such admission is sought subsequent to the extended period prescribed for admission; or
 - (c) on the ground of religion, caste or race, place of birth or any of these reasons.
- 7. The school shall ensure that -
 - (a) no child admitted, shall be held back in any class or expelled from school till the completion of elementary education in a school;

- Act, do not posses the minimum qualifications, shall acquire such qualifications with in a period of 5 years from the date of commencement of the Act.
- (g) the teachers perform their duties, specified under sub-section (l) of section 24 of the Act; and
- (h) the teachers shall not engage himself or herself in any private teaching activities.

- 9. The school shall enroll students proportionate to the norms and standards available in the school as specified in section 19 of the Act.
